**Question 1. LSU Advocacy Fund Fee PASSED 80% YES 312 NO 63**

Do you approve of a new fee of \$1.40 per credit, effective as of January 1, 2018, to be collected by, or for the benefit of, LSU from each student of LSU per semester, which fee is to be used primarily for the LSU Advocacy Fund or pursuant to the Bylaws of the LSU? This LSU Advocacy Fund Fee is a program or service fee pursuant to the *College and Institute Act* (BC), collected in addition to all other LSU fees, and shall increase on an annual basis by the rate of inflation as determined by the consumer price index or pursuant to the Bylaws of the LSU.

**Question 2. LSU Lobby Fund Fee PASSED 83% YES 325 NO 51**

Do you approve of a new fee of \$0.50 per credit, effective as of January 1, 2018, to be collected by, or for the benefit of, LSU from each student of LSU per semester, which fee is to be used primarily for the LSU Lobby Fund or pursuant to the Bylaws of the LSU? This LSU Lobby Fund Fee is a program or service fee pursuant to the *College and Institute Act* (BC), collected in addition to all other LSU fees, and shall increase on an annual basis by the rate of inflation as determined by the consumer price index or pursuant to the Bylaws of the LSU.

**Question 3. LSU Bursary Fund Fee PASSED 84% YES 326 NO 52**

**Question 4. LSU Volunteer Program Fee PASSED 85% YES 333 NO 45**

**Question 6. LSU Student Publication and Marketing Fee PASSED 79% YES 308 NO 66**



**Question 8. Capital Trust Fund Fee PASSED 78% YES 305 NO 71**
